

Licence Extensions

Our standard Licence Agreement excludes the use of our material on some major projects such as large production runs, theatrical releases and commercials. These can however be acquired through special licence extensions which we have made as simple as possible to understand and apply for - and the rates are highly competitive too!

How To Apply

1. First, purchase the track(s) you would like to use in your project. Your download will include a copy of the basic licence for those tracks.
2. Review the rates (below) to help you budget for the music you need. Prices are always 'per track' and each track you can use as many times as you wish within a single project.
3. Complete your project and fill in a **Music Cue Sheet** (downloadable from our Support pages) specifying which tracks have been used. Send this together with a copy of the final product and we will invoice you accordingly.

Please be aware that all other terms of the basic licence remain in effect with the extended licences. Therefore any defamatory or borderline applications must be cleared prior to use. Any product which allows the user to copy, edit or acquire the music is likely to be forbidden. Please contact us if you are in any doubt.

Extended Licence - Rates

All prices are **per Track** and allow **unlimited instances** within the **specified project only**. There is **no charge** for charities, student films, competition entries and other non-profit applications at our discretion, though we do require a copy of the final production. Likewise, there is **no charge** for productions falling under the basic licence or producing less than 5000 units at less than £100 per unit. Please check with us if in any doubt.

Mass Production - Non-Exclusive World Rights

£ 0.003p per Copy + VAT OR £ 0.20p per Unit +VAT (for high value products)
(Applicable after first 5,000 copies) (high-value products are where the retail price exceeds £100 per unit.)

Example 1: 1 track used as opening and closing music on a DVD production run of 25,000 copies. Cost = £ 80 + VAT
Example 2: 1 track on a production run of 1,000 electronic toys retailing at £ 200 per unit.. Cost = £ 200 + VAT

Film & Theatrical Productions - Non-Exclusive World Rights including Trailers

- Only applicable where there is a **paying audience**. - **World broadcast** covered under basic licence.- **Retail rights** as above.
